ABOUT THE FOUNDATION

The Ballarat Foundation consists of a group of Ballarat people who volunteer their time and/or money to help others in the greater Ballarat community on a not-for-profit basis.

We do this by way of a legal structure that has been set up to give the maximum legal tax benefits to our donors, without the hefty costs normally associated with the setting up of these structures.

Established in February, 2001 The Ballarat Foundation is an Honorary Trust and a Company limited by Guarantee. It is incorporated as a Charitable Gift recipient.

The Ballarat Foundation is an independent organisation managed by a community representative, voluntary Board of Directors. Directors are selected on their ability to make a difference and many hold key professional qualifications, knowledge and experience in specific disciplines such as legal and finance.

Board members further manage committees in the areas of Funds Development, Ethics and Allocations, Investment and

Finance and Marketing & Public Relations. The committees are further made up of dedicated professionals in the various fields of expertise associated with each committee.

Since January, 2007, The Ballarat Foundation has employed a full time Chief Executive Officer.

Profits from investments are distributed to groups, organisations and individuals throughout Ballarat and surrounding communities.

We encourage other donors to use The Ballarat Foundation as a highly effective and caring organisation to get the best value for their charitable dollar.

We have a structure that is flexible; this means that we can tailor a method of gifting which is suitable to the needs of individual and corporate donors, including the option of active involvement in the distribution process.



FROM THE CHAIRMAN

The recently concluded year has been one of consolidation for The Ballarat Foundation.

In a year that has seen financial turmoil none of us have seen in living memory life in the area of Philanthropy and Charity have not been easy.

Despite this scenario, the Foundation has on a day to day basis seen an improvement in many areas of its operations. Our CEO, Noel Trengove's time and effort has seen new initiatives and the ongoing development of established programs.

Core sub-funds such as the Telstra County Wide Ballarat Community Sub-fund and the Courier Charity Fund who along with many other sub-funds and donors continue to inject funds into the Foundation and help us connect with the community through the grants made.

To this end, the foundation has to date distributed over one million dollars in grants and support throughout our communities. With the worst of the global financial crisis now hopefully over, our invested capital now stands at some \$1.5 million.

This capital has the opportunity to grow in the coming year as we face the challenge to turn \$100,000 of state government grant into \$400,000 of new corpus. To achieve this significant growth we seek community support to the order of a minimum \$100,000. If we "give where we live" a new an ongoing sub-fund for Wendouree and Delacombe will be here as a permanent means of supporting these communities.

Other very worthwhile and encouraging progress for the year include the 7 Star Low Energy Charity home, supported by FRRR, the Matthew George Young Stockman Award, The Back to school Voucher program and the new Vital Signs program.

All of these activities have been underpinned by a review of the Foundation's asset base and the investment process. For this the Investment committee is most grateful to Prowse, Perrin and Twomey and Peter O'Connell in particular.

As in the past the work of the Marketing & Public Relations Committee, the Funds Development Committee and the Board in general is most appreciated and is acknowledged as critical to the ongoing success of the Foundation.

During the period covered by this report, we have unfortunately lost the services of some key Board members being Val Sarah AM, Kaye Draffin and Garry Lyons. We are all extremely grateful for the work performed and the dedication given by these individuals, not just as Board members but in actively growing the Foundation. I would also offer a belated welcome to John King Jnr. who has joined our Board in May 2008.

As the Foundation looks to the future we are reminded of our catch-cry Now! For the Future. While the economic conditions do appear to be picking up, there will always be



plenty of room for the likes of The Ballarat Foundation. The need to focus at a grass roots community level has never been higher as despite the prosperity and inclusion of many, this is not always the case at all. The Ballarat Foundation seeks the ongoing support of the people of Ballarat and the region to ensure that all not just some are included in the communities in which we live and work.

I again thank my fellow Board members for their ongoing contribution and support of the Foundation and our CEO, Noel Trengove in particular.

FROM THE CEO

In this annual report we are covering the extended period from January 1, 2008 to June 30, 2009. This is in keeping with a decision taken by the Board to move our reporting period to be in line with the financial year rather than the previously used calendar year.

This has meant that a long period has past without the Foundation making any formal report back to the community in regards to its financial and operational position. On top of this, the Global Financial Crisis has had some impact on our investments and earnings, just as it has on every organisation throughout the world.

This annual report therefore is our first opportunity in eighteen months to bring our members and the community up to date with our position as we come out of what is hopefully the end of the GFC.

When the world is in a period of difficulty the demands on not for profit organisations, particularly those that provide funding for programs, increases. Sadly these are also periods when not for profit organisations' own resources are limited or drying up making life doubly difficult.

Through this period we have worked to address the issues that the Board recognised as impinging on the Foundation. The primary area of concern was the need to raise the profile of our brand and to give the community a relationship with The Ballarat Foundation.

The second area is that of lifting the size of our capital base. We have long said we need to get to a point of having a corpus of at least \$5 million to produce adequate income to both run the foundation and provide significant monies to put back into the community for both grass roots grants and major community projects and programs.

Through the last 18 months the corpus growth has been slow, primarily due to the impact and ramifications to the GFC. Individuals and businesses alike have tightened their belts to protect themselves against the fallout, but more importantly their need for tax deductions has reduced as their profitability has declined.

That recognised, the Ballarat Foundation has set about travelling two paths, one being to embark on projects that had the capacity

to provide funds to the Foundation and the other stream to continue to grow our brand and to build a profile that would lead to increased levels of support in the long term.

This was framed at a Strategic Planning day held in April 2008 involving Board members and community representation. Out of this came, amongst other things, the core idea to develop and build a low energy charity home and also to investigate what major 'flagship' community project we could undertake.

As it developed the home project addressed both core aims of lifting our profile whilst also providing the opportunity to raise funds.

The 7 Star Low Energy Charity Home, has become widely known and respected as a place where builders and home renovators can visit to gain knowledge and experience a range of energy saving features which they can consider for their own building projects. Our intent was not to preach to those already involved in energy conservation and ease the strain on the environment, but to appeal to the big percentage of the population who had not yet taken a step in this direction. We felt that if we could just influence every new home builder and renovator to take up



one idea, large or small, then collectively we would make a considerable difference to conserving energy, reducing the greenhouse footprint and in creating a platform for individuals to develop further.

We were fortunate to get tremendous support from Integra Group, The University of Ballarat, FRRR and many businesses and contractors who all contributed to bring this project to completion. The opening was undertaken by the Rt Hon Ian Sinclair on June 24th 2009 and since has been open to the public on weekends and to schools and groups during the week.

To date, this home has achieved all that was expected of it and has received much favourable comment from those who have visited. The home will be sold in coming months.

The Ballarat Foundation undertook a review to identify what flagship projects we might consider and whilst there is no shortage of areas in which this could be undertaken, it was decided that we should do as an advocacy role for all the community rather than single out a specific area of need.

After some months the Foundation decided to take up an opportunity to pilot in Australia, along with three other community foundations, a Canadian model for measuring the health of our community, Vital Signs®.

Vital Signs will be developed through the balance of 2009 and it is envisaged that the first 'report card' will be published in the Ballarat Courier prior to June 2010.

Our effort to expand beyond Ballarat into the region has had some success through our Back to School Voucher Program and also the establishment of our first sub-fund outside Ballarat and in our region.

The Back to School Voucher program is run nationally by FRRR and through this region by The Ballarat Foundation. We seek and provide further support to enlarge the success of the program. In this reporting period we have delivered two 'start of year' programs and one 'winter pilot' program. In February 2008 we more than doubled our previous effort to deliver 472 Vouchers to 24 schools in and around Ballarat. At the start of winter 2008 we ran a pilot program that delivered 75 vouchers for specific cases of need at 9 schools. With further support from the City of Ballarat Community Grants, Rotary Young Ambition, other service clubs and with involvement from the schools themselves the Foundation in February 2009 personally delivered 840 vouchers with a value of \$42,000 to 68 schools across the shires of Ararat, Pyrenees, Hepburn, Moorabool, Golden Plains and City of Ballarat. A further Winter program has been delivered since the end of this reporting period.

September 2008 saw the establishment of the Matthew George Young Stockman Award, a sub-fund set up in memory of Matthew George from Stockyard Hill who was tragically taken in a car accident in November 2007. The funds to establish this sub-fund were raised by Matthew's family, colleagues and friends through a dinner auction held at the Royal Melbourne show, exceeding \$85,000. This fund will send one young stockman overseas each year on a study tour to learn about and bring back knowledge to the local Cattle breeding industry.

Recognising that when belts tighten, the need grows, The Ballarat Foundation in its 2008 grant's round adopted the strategy that although income was down, we should draw on capital and maintain if not exceed the level of support available for community grants. In November 2008, grants totalling \$27,000 were made to six community organisations at a ceremony held at Delacombe Primary School.

Our Telstra Country Wide Ballarat Community Sub-fund continues to make grants twice yearly with three distributions undertaken during this reporting period. At the last round, the eighth since inception this sub-fund gave out 11 grants totalling \$33,335. In all a total of \$302,600 has been distributed over the three and a half years of operation. This is a remarkable effort and we thank Telstra for their support.

The Courier Charity Sub-fund has also been active with a \$10,000 grant to McCallum Disability Services in early 2009. Also this year with the donation of land in the Sylvan Lodge Estate in Delacombe by Barry and Lois James, a 4 bedroom energy efficient home is under construction for sale which will boost the capital position of this sub-fund.

After twelve months of development and a lot of work on our part, The Ballarat Foundation was ecstatic to be awarded one of four grants from the state government to establish a new sub-fund, ours being in support of Wendouree and Delacombe. Whilst finalised in this financial year, the public announcement was not made by Minister Peter Batchelor under August 2009. The grant received is an initial \$100,000 which we are challenged to match through new pledges over the next twelve months. If matched, the government will provide a further \$200,000 which will give a minimum of \$400,000 capital for the fund to draw earnings from into perpetuity. We have also made an application on behalf of Ararat which we hope will be successful with this application in future rounds.

In both 2008 and 2009 the Foundation sought membership donations to assist with the funding of administration. Whilst very worthwhile and most appreciated from those that were able to contribute, the total was less in 2009 than 2008, a reflection of the economic times. We also received significant

support from the City of Ballarat and in March 2009 was successful in attaining a Community Foundation sustainability grant from FRRR, which will run over three years.

At the last Annual General meeting we saw the largest single turnover of Board Members as many of the original board reached their maximum period of membership. In early 2008, the Foundation held an event to recognise the great contribution made by these Board members.

Since then and in these times of extreme demand on people's time, we have unfortunately lost three Board members in Val Sarah AM, Kaye Draffin and Garry Lyons. Whilst intentionally running slightly under our maximum, the Foundation was extremely pleased to be able to welcome John King (Jnr) to the Board in May 2008. I would like to publicly thank my Board, past and present and our committees for their support and guidance through this period.

Some other highlights through the period include:

- The establishment of the Peter Doherty Science Prize sub-fund created with \$5,000 contribution from Committee for Ballarat. This fund will offer prizes to year 10 and 11 students for a science related school project.
- The Ballarat Foundation Scholarship Trust was established.
- Induction and Training Manual was established to improve governance and training of Board members.
- Local business, Premier PR undertook market research for the Foundation which gave our Board an insight into various strengths and weaknesses of the Foundation; and is being used to drive some changes as we move forward, particularly in the area of communication and branding.
- We commenced the establishment of an arrangement with the Commonwealth Bank which will lead to the Foundation receiving referral income from home and business loans generated through the Foundation.
- In a long term initiative, we are actively offering our services to a number of planned regional community groups that may see the Foundation run sub-funds on behalf of these communities and/or groups.

• In conjunction with the Buninyong Golf Club we were the recipients of the funds raised at Par 3 golf day held in October.

- We continue to produce newsletters and other marketing material and run occasional adverts for specific events and programs.
- A new sub-fund was established with an anonymous donor.
- We upgraded our existing website in 2008 are now working to complete development of a totally new website by early 2010.
- We commenced developing the production of Community Service Announcement, television commercial which will run on the three local commercial networks commencing October 2009.
- Looked at a potential parcel of land to develop.

Since the foundation's inception we have put over \$1,000,000 back into the local community through grants and support.

It is rewarding to note that through this reporting period we have managed through the GFC and have with community support grown our corpus from \$1,042,000 to close to \$1,445,000 although we have a long way to go to achieve our near term target of \$5,000,000.

Through the reporting period we have witnessed considerable change in the way the Foundation operates. Both our own development and the need to adapt with the changing economic climate has seen us move from the traditional model of simply seeking donated corpus funds and making simple grants to one of self generation of funding, of building relationships with donors and recipients, of advocacy and providing knowledge and information to the community. As these changes continue we too will continue to change with them and as donations become more affordable to both individuals and business, it is our hope and wish that we will both seek their generosity and grow the corpus funds for the communities benefit into perpetuity.

FUNDS DEVELOPMENT

This year has seen some exciting developments in the funds development area, under the Chairmanship of Garry Lyons. Unfortunately Garry resigned midway through the year. Garry brought great enthusiasm and dedication to the portfolio. Much of our progress this year can be attributed to Garry's hard work. His contribution to the board will be greatly missed.

It would be fair to say that it has been a challenging year for funds development. Whilst the impact of the GFC has not been as great as feared, it has inevitably impacted on citizens philanthropic donations. Despite this we are looking forward to an exiting year ahead with the foundation planning a high profile event for 2010.

There are three activities I would like to focus on:

- The Foundation has built a 7stare rated, low energy home. This project will benefit the Foundation and community in; Show casing innovative design and products, which will reduce a family's carbon foot print and reduce household running expenses. The construction and promotion of the house has strengthened the Foundations standing and profile within the community. The house is currently on the market, with the board

anticipating a surplus to further strengthen the funds position. The Foundation has had wonderful support from many organisation and individuals during this project. The support of Integra Group deserves special comment. Integra's support has been pivotal during the project. The foundation is privileged to have the ongoing support of the Integra Group.

- This year has seen the establishment of the Matthew George Young Stockman Award. Matthew was a fine young man with a keen interest in cattle production. His untimely death has been keenly felt by his family and community. The George family has worked with the Foundation to develop the sub fund in memory of Matthew. The inaugural recipient of the award, Clare Bruggemann has received funding enabling her to further her expertise in cattle husbandry in Canada and to bring back her knowledge to share with other local breeders.

- Via an initiative of the State Government the Wendouree Delacombe sub-fund has been developed. The Foundation has been given \$100,000 to establish the fund. If we can match these funds with donations from the Ballarat community, increasing the fund to \$200,000, the Government will put in a further

\$200,000. This will establish a \$400,000 fund. This is a wonderful opportunity for donors to effectively leverage their donation. Effectively turning every \$1 donated into \$4. Naturally, the foundation is very excited by this opportunity and will soon be launching a campaign to achieve the target.

The Foundation is very fortunate to have the support of the Ballarat community and for this we are very appreciative. My thanks to the Sub Committee members and with our extremely diligent and hard working CEO, Noel Trengove, we look forward to a productive and exciting year ahead.

ETHICS AND ALLOCATIONS

Whilst members of The Ballarat Foundation find all aspects of the Foundations work rewarding, I believe it is in the allocations area that we find most interest. That is because we gain some insight into the great organisations that operate within the Ballarat community. These organisations are made up of hard working, dedicated and resourceful citizens. Many of the projects we access display levels of initiative and imagination which are a credit to these citizens and the community. We are indeed fortunate to live in such a vibrant community.

Due to the change in the Foundations reporting year, there has been two funding rounds since we last reported. 2008 again saw an increase in the number of applicants with an unexplained reduction in applicants in 2009. I trust this is an anomaly and does not reflect a reduction in community participation in the future.

We have received funding applications from many varied groups reflecting the whole range of human endeavor and concern.

Once again we have partnered with other organizations in order to support the Ballarat community. The partnership with the Courier Charitable Fund and the Telstra Country Wide Ballarat Community Fund has proved

to be sound and beneficial for all involved. This year saw the Telstra Country Wide Fund exceed \$300,000 in funds distributed to the community, since its inception.

The Ethics and Allocations committee has developed a sound process for assessing the merits of each application; however continuous improvement is still being pursued. As always we receive more applications than we are able to support. Our inability to support an application does not reflect on the individual applicants. Our fund is still growing and developing, and with the continued support of the community, will be well positioned to support many generations to come.

Since we last reported, the committees long serving Chairman John Abraham has retired. The Board is very great full for the leadership and commitment John has afforded to the Foundation.

The Board is very appreciative of the work put in by the members of the sub-committee. They all diligently tackle there responsibilities and do so willingly.
